### Hadith of The Week

"Narrated by Abu Hurairah رضى الله عنه. The Messenger of Allah said: "The most perfect in faith among the believers is the one whose character is best." (Recorded by Al-Tirmidhi)

Meaning: This Hadith emphasizes that true faith perfection is directly linked to one's moral character through actions and demeanor. Three Types of People: Re-reading al-Bagarah

Surah Al-Baqarah, the longest chapter of the Qur'an and primarily revealed in Madinah, begins by categorizing humanity into distinct groups, setting a foundational understanding of human responses to divine truth. It first introduces two types of people familiar to Prophet Muhammad (= peace be upon him) from the Meccan period: the sincere believers and the overt disbelievers. The believers are described as those who readily accept the unseen, establish prayer, spend from what Allah & has provided, and affirm all divine revelations; for them is guidance and ultimate success. In stark contrast, the disbelievers are portraved as those whose hearts and ears are sealed by their stubborn rejection, making them impervious to warning and destined for a severe punishment.

As the Muslim community gained strength and established a state in Madinah, a third and more insidious category emerged, one that posed a unique challenge: the hypocrites (al-Munafique). These individuals outwardly declared their belief in Allah , the Last Day, and the Prophet , often participating in Muslim rituals. However, their inner reality was one of concealed disbelief, doubt, and often malicious intent. The Qur'an meticulously exposes their deceptive nature, describing them as attempting to "deceive Allah and those who believe," while, in reality, they deceive only themselves. Their characteristics include indecisiveness, mockery, spreading mischief, and a fundamental sickness in their hearts that Allah intensifies.

This tripartite classification at the very beginning of Surah Al-Bagarah is crucial because it provided Prophet Muhammad sand the nascent Muslim community with a comprehensive framework for understanding the diverse human landscape they would navigate. While overt disbelievers presented an external challenge, the hypocrites represented an internal threat, far more dangerous due to their hidden animosity and subversive actions from within the Muslim ranks. By meticulously detailing the traits of the hypocrites, the Surah served as a powerful divine warning, equipping believers with discernment and highlighting the spiritual and social foundations necessary to build a truly pure and resilient Islamic society amidst varying human inclinations.



### C Reflection



What is Hijrah Dr. Hatim Hegab July 19, 2025

The Hijrah, or migration, holds immense significance in Islamic history, marking the pivotal journey of Prophet Muhammad and his companions from Makkah to Madinah in 622 CE. This was not merely a change of location, but a strategic move born out of intense persecution and the search for a safe haven to practice Islam freely. Faced with severe oppression, the Prophet sand his followers left behind their homes, livelihoods, and tribal ties in pursuit of a land where they could establish the principles of justice, brotherhood, and the worship of One God (Allah 製氣) without fear. This momentous event became the cornerstone of the nascent Muslim community, leading to the establishment of the first Islamic state and the very beginning of the Islamic calendar.

Beyond its historical context, the concept of Hijrah carries a profound spiritual meaning that remains perpetually relevant for every Muslim. It embodies the constant, internal migration from all that is displeasing to Allah J towards all that is righteous and virtuous. This can mean abandoning sin for repentance, replacing ignorance with knowledge, and trading heedlessness for constant remembrance of Allah . The Hijrah thus symbolizes a continuous journey of self-purification, sacrifice for the sake of one's faith, and perseverance in the face of challenges, always striving to move from a state of spiritual stagnation to one of growth and deeper submission to divine will. It is a timeless call for personal transformation and the establishment of truth and justice wherever one may be.

# Lawsuit blocking Trump's birthright citizenship



A U.S. District judge in New Hampshire has certified a class action lawsuit filed by the ACLU that challenges President Trump's executive order limiting birthright citizenship, potentially applying relief to all babies born in the U.S. after June 27, regardless of their state. This includes states like Oklahoma that were not part of the original suits. Although the Supreme Court recently curtailed nationwide injunctions from lower courts, this ruling illustrates that broad legal relief remains possible through class action lawsuits. The judge stayed the injunction until July 27 to allow time for a federal appeal, but legal experts note class actions and the Administrative Procedure Act still offer valid legal tools against executive actions.

Legal scholars warn that if the executive order is allowed to take effect in select Republican-led states while class actions are pending, a confusing legal disparity could emerge where a child's citizenship depends on the state of birth—something not seen since the Civil War. Some plaintiffs, like those from organizations based in Oklahoma, may remain protected, but overall enforcement could result in a patchwork of coverage. Oklahoma law-makers, including Senators Mullin and Lankford,

support Trump's order and the Supreme Court's recent decision limiting judicial overreach, emphasizing the importance of maintaining the separation of powers rather than allowing courts to issue nationwide rulings outside their jurisdiction.

#### SPS Will Recieve Funds



At the July 8 Stillwater Public Schools Board of Education meeting, concerns were raised about the potential delay of state and federal funding earmarked for public schools, with particular focus on whether federal sources like Title funds might be withheld or affect state allocations. Board member Marshall Baker questioned how such uncertainties might impact budget planning, while CFO Kristie Newby explained that the district expected approved federal funds to arrive eventually, viewing the delay as more procedural than substantive—though still frustrating. Superintendent Tyler Bridges emphasized that federal law limits Title fund cuts to 10% per year and doubted major disruptions, given the scale and pre-approval of the funds, but acknowledged the unprecedented uncertainty caused by a stated federal funding freeze. While the district's budget for the 2025-26 school year anticipates over \$29 million in state and \$3.3 million in federal revenue, administrative leaders are preparing contingency plans, but remain optimistic that the funding will ultimately be released.
